The Daughters of Our Lady of Compassion, usually known as the Sisters of Compassion, was founded by Suzanne Aubert in 1892. It remains the only New Zealand-founded congregation of Sisters.

For more than a century, the Sisters have taught, nursed and provided homes for children, frail and elderly people in New Zealand and the South Pacific. Their mission is to be a practical example of Christian love to all and strive to meet the needs of those society tends to ignore.

The Sisters, and the staff they inspire, are committed to deliver compassionate care throughout their community by providing meals, food and basic needs to those who have very little; caring for the elderly, and providing individual and family support. They are committed to supporting those of all creeds and none.




The Sisters and their staff provide compassionate care in four main centres:

In **Wellington City**, the Compassion Centre includes the city's soup kitchen.

The home of the Sisters in **Island Bay**, is also a Retreat House; a place of prayer and pilgrimage where people can refresh and recharge from life's pressures.

St Joseph's Home of Compassion Rest Home and Hospital at **Heretaunga** is a care facility for elderly people, which also caters especially for people with dementia.



The Sisters also run Chanel Home for the elderly and those with disabilities in **Suva**, **Fiji**.





Amid the challenging and fast-changing world around us, the Sisters and their staff continually adapt to ensure they meet the calls for help, no matter what form they take, without judging or condemning.

In answering God's call to feed the hungry, clothe the naked, visit the sick and imprisoned and to try and see the face of Christ in all, the needs are great and the demands are just as many.

It takes significant financial support to provide compassionate care. The Sisters rely heavily on donations from individuals. They can only do what they do, responding to people in need, because of the generosity of supporters like you.

The donations the Sisters receive enable them and their staff to carry out their mission, including providing support for those who visit the soup kitchen or live at St Joseph's Home of Compassion. They enable them to work with Māori Pastoral teams and in other chaplaincy work up and down the country.

LEAVING BEHIND A WILL - A HELPFUL GUIDE

A Will is a valuable personal document. Once you have made one, you can be sure your estate will be distributed according to your wishes. In the absence of a Will, your estate is divided according to the law.

To ensure that the people and causes that matter to you most are taken care of when you are gone, it is vital to make sure your Will is always up to date.

The need-to-knows

- Everybody over the age of 18 should have a legal and up-to-date Will.
- A solicitor or a trust company can help you draw one up.
- · You need to nominate a guardian for young children in your care.
- Your Will must incorporate new and relevant amendments to the law (such as tax or superannuation) or it may be considered invalid.
- Your executor and at least one other person need to know where the Will is kept.

If your family or marital situation changes - through marriage, defacto marriage, divorce, births or deaths - or if your financial status changes significantly, you should update your Will accordingly.

The easiest way to change your Will

You don't need to create a whole new Will if you decide you would like to include a bequest to the Sisters of Compassion. You can simply add a clause known as a codicil. It is not complicated or expensive and often does not involve much more than advising your family solicitor or legal advisor of the desire to make a bequest to the Sisters and using wording similar to that in the *Codicil for Existing Will* page of this document.

Adding a codicil to my Will

Making provision for the Sisters of Compassion in your Will requires adding a codicil. The wording on the **Codicil for Existing Will** page is the type that you can use when consulting with your legal advisor.

Your Bequest: An enduring contribution to the future
